### Jury Awards \$8 Million Verdict in Mesothelioma Case

After a trial lasting several days, a former employee of Eastman Kodak, Wayne Meissner, was awarded a verdict in the amount of \$8 million. State Supreme Court Justice John J. Ark presided over the trial. Wayne Meissner and his wife, Jill, were represented by Attorneys John P. Comerford and Mathew J. Morton. Mr. Meissner was diagnosed with mesothelioma in July 2018.

Mesothelioma is a rare and incurable form of cancer caused by exposure to asbestos. Wayne Meissner is a lifetime non-smoker, although smoking has no connection to the development of mesothelioma. He was occupationally exposed to asbestos over a period of several years beginning in the late 1960s. He experienced a particularly intense period of exposure while working at Kodak Park as a civil engineer. In 1970 he monitored and inspected a job involving the spray application of asbestos performed by Ridge Construction, a subsidiary of Eastman Kodak. Ridge Construction failed to take steps to warn Mr. Meissner of the risks of exposure to asbestos and also failed to protect him from exposure to the deadly mineral fiber.

## NYS Court of Appeals Holds Coke Oven Manufacturers Have A Duty to Warn

n June 11, 2019, New York State's highest court affirmed that manufacturers of coke ovens have a duty to warn about the latent dangers of their products. Coke ovens are vast, industrial ovens that are used to transform coal into coke, a solid fuel used in the manufacture of steel. Until the imposition of engineering controls and the mandatory use of respiratory protection in the late 1970's, the ovens, when used intended, exposed the workers cancer-causing dangerous emissions.

T ipsitz & Ponterio, LLC represents Lithe Estate of Donald Terwilliger. Mr. Terwilliger spent most of his career as a coke oven worker at Bethlehem Steel in Lackawanna, New York. Beginning in 1966, Mr. Terwilliger was exposed to carcinogenic emissions released by the coke ovens. Despite knowing that its ovens posed a deadly hazard, the ovens' manufacturer never warned workers, like Mr. Terwilliger, about the dangers the ovens posed. When Mr. Terwilliger's Estate sued the coke oven's manufacturer, the defendant Cont'd. on Pg. 2

argued that, even if it knew that using its ovens as intended could kill the users, the manufacturer did not have any duty to warn users, because the coke ovens were so large that they should not be considered products. The oven is too big be a product,

the defendant insisted, and if it is not a product, then the company that made it is entitled to sell it in a dangerous condition.

On June 11, 2019, after a multi-year legal battle, the Court of Appeals rejected this argument and confirmed the longstanding New York rule that a manufacturer has a duty to warn about the latent dangers of the machinery it sells – even if its machines are very large, or are constructed into a larger building. This decision is a victory for the rights of New Yorkers injured by industrial negligence. John N. Lipsitz, Dennis P. Harlow, and Mathew J. Morton handled this appeal.

"Today a jury in Monroe County said 'No More!' to the careless behavior of the asbestos industry."

The \$8 million verdict was allocated 80% to the wrongdoing of Ridge Construction, and 20% was allocated to other responsible parties. The jury also found that the conduct of Ridge Construction was reckless.

Wayne Meissner is 73 years old. He and his wife have been married for forty-eight years, and they have four adult children.

#### Child Victims' Act Signed Into Law in New York State



n February 19, 2019, New York State Governor Andrew Cuomo signed into law the Child Victims Act, which extends the statute of limitations for a survivor of child sexual abuse in civil and criminal cases in New York. Previously, a survivor of child sexual abuse would have had to file a civil lawsuit by the time they reached the age of 21, or their case would be time barred.

mong other things, this **A**legislation originally:

- •Increased the amount of time during which perpetrators of these crimes may be held criminally accountable;
- •Allowed victims of these crimes to commence a civil lawsuit at any time before they reach the age of 55;
- •Eliminated the need to file a Notice of Claim for sexual offenses committed against a minor; and
- •Provided victims whose claims have been time-barred a new opportunity by opening a one-year window for them to commence their action, from August 14, 2019 to August 14, 2020.

In light of the coronavirus Loutbreak, the New York State's Unified Court System suspended the filing of new lawsuits while the state worked to flatten the curve. As a result, the Governor issued Executive Order 202.29 on May 8, 2020, which extended the filing deadline for Child Victims Act cases from August 14, 2020 to January 14, 2021. The New York State Senate and Assembly subsequently passed legislation on May 26, 2020 extending the ultimate filing deadline until August 14, 2021, granting victims an extra year to file. This Bill was signed into law by Governor Cuomo on August 3, 2020.

Insurprisingly, when the window for claims opened on August 14, 2019, hundreds of cases were filed under the Child Victims Act. and thousands more have been filed since. The Catholic Dioceses and The Boy Scouts of America are among the defendants listed in these lawsuits. Other cases have also been brought directly against abusive members of the victims' families.
